1.0 INTRODUCTION

This report has been compiled to provide a monthly summary of environmental monitoring results for Mt Thorley Warkworth (MTW). This report includes all monitoring data collected for the period 1 June to 30 June.

2.0 AIR QUALITY

2.1 Meteorological Monitoring


Meteorological data is collected at MTW's 'Charlton Ridge' meteorological station (refer to **Figure 3**: Air Quality Monitoring Locations).

2.1.1 Rainfall

Rainfall for the period is summarised in **Table 1**, the year-to-date trend and historical trend are shown in **Figure 1**.

2.1.2 Wind Speed and Direction




Figure 2: Charlton Ridge Wind Rose - June 2021

Winds from the north west were dominant throughout the reporting period as shown in **Figure 2**.




Figure 3: Air Quality Monitoring Locations

2.2 Depositional Dust

To monitor regional air quality, MTW operates and maintains a network of seven depositional dust gauges, situated on private and mine owned land surrounding MTW.




Figure 4: Depositional Dust - June 2021

Figure 4 displays insoluble solids results from depositional dust gauges during the reporting period compared against the year-to-date average and the annual impact assessment criteria.

During the reporting period the Warkworth monitor recorded a monthly result above the long-term impact assessment criteria of 4.0 g/m²per month. There is no evidence to suggest that the Warkworth result is contaminated. Accordingly, the result will be included in the annual average calculation.

An annual assessment of MTW's compliance with the Long-Term Impact Assessment Criteria will be provided in the 2021 Annual Review Report.

2.3 Suspended Particulates

Suspended particulates are measured by a network of High Volume Air Samplers (HVAS) measuring Total Suspended Particulates (TSP) and Particulate Matter <10 μ m (PM₁₀). The location of these monitors can be found in **Figure 3**. Each HVAS was run for 24 hours on a six-day cycle in accordance with EPA requirements.

2.3.1 HVAS PM₁₀ Results




Figure 5: Individual PM₁₀ Results – June 2021

Figure 5 shows the individual PM_{10} results at the monitoring station against the short-term impact assessment criteria of $50\mu g/m^3$.




Figure 6: Annual Average PM₁₀ - June 2021

2.3.2 TSP Results




Figure 7: Annual Average Total Suspended Particulates – June 2021

Figure 7 shows the annual average TSP results compared against the long-term impact assessment criteria of 90μg/m³.

An annual assessment of MTW's compliance with the Long-Term Impact Assessment Criteria will be provided in the 2021 Annual Review Report.

2.3.3 Real Time PM₁₀ Results

Mt Thorley Warkworth maintains a network of real time PM_{10} monitors. The real-time air quality monitoring stations continuously log information and transmit data to a central database, generating alarms when particulate matter levels exceed internal trigger limits.




Figure 8: Real Time PM10 24hr average and Year-to-date average – June 2021

Results for real time dust sampling are shown in **Figure 8**, including the daily 24-hour average PM_{10} result and the annual PM_{10} average.

2.3.4 Real Time Alarms for Air Quality

During **June**, the real-time monitoring system generated 41 automated air quality related alerts, including 24 alerts for adverse meteorological conditions and 17 alerts for elevated PM10 levels.

3.0 WATER QUALITY

MTW maintains a network of surface water and groundwater monitoring sites.

3.1 Surface Water

Monitoring is conducted at mine site dams and surrounding natural watercourses. The surface water monitoring locations are outlined in **Figure 15**.

Surface water courses are sampled on a monthly or quarterly sampling regime. Water quality is evaluated through the parameters of pH, Electrical Conductivity (EC) and Total Suspended Solids (TSS). The Hunter River and the Wollombi Brook are sampled both upstream and downstream of mining operations, to monitor the potential impact of mining. Other Hunter River tributaries are also monitored.

3.1.1 Surface Water Monitoring Results




Figure 9: Site Dams Electrical Conductivity Trend – June 2021

Figure 9 to Figure 11 show the long-term surface water trend (2018 – current) within MTW mine dams. Figure 12 to Figure 14 show the long-term surface water trend (2018 - current) in surrounding watercourses.




Figure 10: Site Dams pH Trend – June 2021






Figure 11: Site Dams Total Suspended Solids Trend – June 2021





3.1.2 Surface Water Trigger Tracking

Internal trigger limits have been developed to assess monitoring data on an on-going basis, and to highlight potentially adverse surface water impacts. The process for evaluating monitoring results against the internal triggers and subsequent responses are outlined in the MTW Water Management Plan.

Current internal surface water trigger limit breaches are summarised in Table 2.

3.2 HRSTS Discharge

MTW participates in the Hunter River Salinity Trading Scheme (HRSTS), allowing discharge from licensed discharge points located at Dam 1N and Dam 9S. Discharges can only take place subject to HRSTS regulations.

MTW did not undertake any HRSTS discharges in the reporting period.




Figure 15: Surface Water Monitoring Location Plan




Figure 16: Bayswater Seam Electrical Conductivity Trend – June 2021

Figure 16 to Figure 61 show the long-term water quality trends (2018 – current) for groundwater bores monitored at MTW.




Figure 17: Bayswater Seam pH Trend – June 2021




Figure 18: Bayswater Seam Standing Water Level Trend – June 2021




Figure 19: Blakefield Seam Electrical Conductivity Trend – June 2021




Figure 20: Blakefield Seam pH Trend – June 2021




Figure 21: Blakefield Seam Standing Water Level Trend – June 2021




Figure 22: Bowfield Seam Electrical Conductivity Trend – June 2021




Figure 23: Bowfield Seam pH Trend – June 2021




Figure 24: Bowfield Seam Standing Water Level Trend – June 2021




Figure 25: Redbank Seam Electrical Conductivity Trend – June 2021




Figure 26: Redbank Seam pH Trend – June 2021




Figure 27: Redbank Seam Standing Water Level Trend – June 2021




Figure 28: Shallow Overburden Electrical Conductivity Trend – June 2021




Figure 29: Shallow Overburden pH Trend – June 2021




Figure 30: Shallow Overburden Standing Water Level Trend – June 2021




Figure 31: Vaux Seam Electrical Conductivity Trend – June 2021




Figure 33: Vaux Seam Standing Water Level Trend – June 2021




Figure 34: Wambo Seam Electrical Conductivity Trend – June 2021




Figure 35: Wambo Seam pH Trend – June 2021




Figure 36: Wambo Seam Standing Water Level Trend – June 2021




Figure 37: Warkworth Seam Electrical Conductivity Trend – June 2021




Figure 38: Warkworth Seam pH Trend – June 2021




Figure 39: Warkworth Seam Standing Water Level Trend – June 2021




Figure 40: Wollombi Alluvium Electrical Conductivity Trend – June 2021



Figure 41: Wollombi Alluvium pH Trend – June 2021




Figure 42: Wollombi Alluvium 2 Electrical Conductivity Trend – June 2021




Figure 43: Wollombi Alluvium 2 pH Trend – June 2021




Figure 44: Wollombi Alluvium Standing Water Level Trend – June 2021




Figure 45: Woodlands Hill Seam Electrical Conductivity Trend - June 2021




Figure 46: Woodlands Hill Seam pH Trend - June 2021




Figure 47: Woodlands Hill Seam Standing Water Level Trend - June 2021




Figure 48: Aeolian Warkworth Sands Electrical Conductivity Trend – June 2021




Figure 49: Aeolian Warkworth Sands pH Trend – June 2021




Figure 50: Aeolian Warkworth Sands Standing Water Level Trend – June 2021




Figure 51: Hunter River Alluvium 1 Electrical Conductivity Trend – June 2021




Figure 52: Hunter River Alluvium 1 pH Trend – June 2021




Figure 53: Hunter River Alluvium 2 Electrical Conductivity Trend – June 2021




Figure 54: Hunter River Alluvium 2 pH Trend – June 2021





Figure 55: Hunter River Alluvium 3 Electrical Conductivity Trend – June 2021




Figure 56: Hunter River Alluvium 3 pH Trend – June 2021

Figure 58: Hunter River Alluvium 4 pH Trend – June 2021




Figure 59: Hunter River Alluvium 5 Electrical Conductivity – June 2021




Figure 60: Hunter River Alluvium 5 pH Trend – June 2021




Figure 61: Hunter River Alluvium Standing Water Level Trend – June 2021

3.2.1 Groundwater Trigger Tracking




Figure 62: Groundwater Monitoring Location Plan

Internal trigger limits have been developed to assess monitoring data on an on-going basis, and to highlight potentially adverse groundwater impacts. The process for evaluating monitoring results against the internal triggers and subsequent responses are outlined in the MTW Water Management Plan. Locations of groundwater bores are shown in **Figure 62**.

4.0 BLAST MONITORING

MTW have a network of six blast monitoring units. These are located at nearby privately-owned residences and function as regulatory compliance monitors.

The location of these monitors can be found in Figure 69.

4.1 Blast Monitoring Results




Figure 63: Abbey Green Blast Monitoring Results - June 2021

During June 2021, 18 blasts were initiated at MTW. Figure 63 to Figure 68 show the blast monitoring results for the reporting period against the impact assessment criteria. The criteria are summarised in **Table 4**.

During the reporting period two blasts exceeded the 115 dB(L) 5% threshold for airblast overpressure, one at the MTIE blast monitoring location and one at the Bulga blast monitoring location. No blasts exceeded the 5mm/s 5% threshold for ground vibration.





Figure 64: Bulga Village Blast Monitoring Results – June 2021




Figure 66: Warkworth Blast Monitoring Results - June 2021




Figure 68: Wollemi Peak Road Blast Monitoring Results - June 2021




Figure 69: Blast and Vibration Monitoring Location Plan

5.0 NOISE




Figure 70: Noise Monitoring Location Plan

Routine attended noise monitoring is carried out in accordance with the MTW Noise Management Plan. A review against EIS predictions will be reported in the Annual Review Report. The purpose of the noise surveys is to quantify and describe the acoustic environment around the site and compare results with specified limits. Unattended monitoring (real time noise monitoring) also occurs at five sites surrounding MTW. The attended noise monitoring locations are displayed in **Figure 70.**

5.1 Attended Noise Monitoring Results

Attended monitoring was conducted at receiver locations surrounding MTW on the night of 1 June 2021. All measurements complied with the relevant criteria. Results are detailed in **Table 5** to **Table 8**.

5.1.1 WML Noise Assessment

Compliance assessments undertaken against the WML noise criteria are presented in **Table 5** and **Table 6**.

5.2 Noise Management Measures

A program of targeted supplementary attended noise monitoring is in place at MTW, supported by the real-time directional monitoring network and ensuring the highest level of noise management is maintained. The supplementary program is undertaken by MTW personnel and involves:

- Routine inspections from both inside and outside the mine boundary;
- Routine and as-required handheld noise assessments (undertaken in response to noise alarm and/or community complaint), comparing measured levels against consent noise limits; and
- Validation monitoring following operational modifications to assess the adequacy of the modifications.

Where a noise assessment identifies noise emissions which are exceeding the relevant noise limit(s) for any particular residence, modifications will be made so as to ensure that the noise event is resolved within 75 minutes of identification. The actions taken are commensurate with the nature and severity of the noise event, but can include:

- Changing the haul route to a less noise sensitive haul:
- Changing dump locations (in-pit or less exposed dump option)
- Reducing equipment numbers;
- Shut down of task; or
- Site shut down.

A summary of these assessments undertaken during June are provided in **Table 11**.




Figure 71: Operational Downtime by Equipment Type – June 2021




Figure 72: Rehabilitation YTD – June 2021
