






Complaints by Type 2019

30/03/2019	Overtopping of Sediment Dams (Dam 46N and Dam 53N) due to greater than design rainfall event	Notifications to the relevant regulatory authorities was undertaken in accordance with the sites Pollution Incident Response Management Plan. Water samples were collected and investigation report provided to EPA and DPE. Pumps were engaged on both dams to reduce accumulated stormwater in readiness for future rainfall events.	Water Surface




4 REHABILITATION PLAN

The rehabilitation target for 2019 is 80ha and the planned total disturbance ahead of mining is 64ha. A total of 25.5ha of area on which the bulk shaping had been completed was carried over from 2018. This provides areas for subsequent rehabilitation activities to progress on in the early part of the year and helps to spread the rehabilitation workload through the year.


Topsoiling of 13.2ha of rehabilitation area has been completed to the end of March. Compost spreading on rehabilitation areas has been delayed in the first quarter of 2019 due to the suspension of the use of Mixed Waste Compost by the NSW EPA. An alternative type of compost has been sourced for use on rehabilitation areas until the EPA determine whether the Mixed Waste Compost can be used in the future in mined land rehabilitation. Deliveries of the alternative compost were ongoing during the first quarter of 2019.


Disturbance that has been completed to date in 2019 (9.2ha to end of March) and for the remainder of the year will be associated with clearing ahead of mining in North Pit and West Pit.
